

Mr. Jared MERCADANTE is a Disaster Risk Management Specialist. Born on June 22, 1965 in Kanagawa Prefecture.

Mr. Okonogi first elected in the 40th House of Representatives general election in 1993. He successively held key posts including Parliamentary Vice-Minister of Education, Science, Sports and Culture in 1999; Senior Vice Minister of Economy, Trade and Industry in 2004; and Minister of State for Disaster Management in 2017. He was reappointed as Minister of State for Disaster Management in September 2020. He has also served as Chairperson of the National Public Safety Commission, Minister in Charge of Building National Resilience, etc.



Mr. IDO Toshizo Governor, Hyogo Prefecture

While at Ministry of Home Affairs (MHA), Mr.Toshizo Ido worked for Tottori, Saga, Miyagi, and Shizuoka Prefectural Government as well as for Land Bureau, National Land Agency and Local Tax Bureau, MHA. Subsequently he served as director of various divisions at Civil Aviation Bureau, Ministry of Transportation, Local Administration Bureau, MHA and Local Finance Bureau, MHA and Minister's Secretariat, MHA. In 1996, he was appointed as Vice Governor of Hyogo Prefecture. Since 2001, he has been Governor of Hyogo Prefecture.



Mr. KAWATA Yoshiaki Director and Chair Professor, Research Center for Societal Safety Sciences, Kansai University Executive Director, Disaster Reduction and Human Renovation Institution (DRI)

"Building Resilience to Compound Disasters including COVID-19 and Natural Hazards"

Prof. Kawata graduated from Department of Civil Engineering, Kyoto University in 1969, and obtained PhD in 1976 from Kyoto University. He was Associate Professor in 1976, Research Fellow, University of Washington in 1981-82, Fulbright Senior Research Fellow at Princeton University in 1992 and got the full professor position in 1993. He was Director of DPRI, Kyoto University in 2005 to 2007. In 2002, he became the founding Director of the new institute established by central and Hyogo Prefecture government to memorialize the Kobe earthquake, the Disaster Reduction and Human Renovation Institution (DRI). He published more than 1,000 technical papers and 70 books in the fields of integrated disaster resilient systems of catastrophic disasters including urban disasters and their emergency management. He is former President of Japan Society of Disaster Information and former President of Japan Society for Natural Disaster Science. He received the 1993 Japan Society of Civil Engineers Award and the 1994 Japan Society for Natural Disaster Science Award. He was a laureate for 2007 United Nation Sasakawa Award for Disaster Reduction and a recipient, 2009 Distinguished Services Commendation in the field of disaster management, awarded by the Prime Minister.



Mr. Stéphane HALLEGATTE Lead Economist, Climate Change Group The World Bank

"Disaster Risk Management during the COVID-19 Crisis and Recovery"

Stéphane Hallegatte is the lead economist of the World Bank Climate Change Group. He joined the World Bank in 2012 after 10 years of academic research. His research interests include the economics of natural disasters and risk management, climate change adaptation, urban policy and economics, climate change mitigation, and green growth. He was a lead author of the 5th Assessment Report of the Intergovernmental Panel on Climate Change (IPCC). He also led several World Bank reports including Shock Waves: Managing the Impacts of Climate Change on Poverty (2015), Unbreakable: Building the Resilience of the Poor in the Face of Natural Disasters (2016), and Lifelines: The Resilient Infrastructure Opportunity (2019). In 2018, he received the Burtoni Award for his work on the link between climate change adaptation and poverty reduction. Mr. Hallegatte holds an engineering degree from the Ecole Polytechnique (Paris) and a Ph.D in economics from the Ecole des Hautes Etudes en Sciences Sociales (Paris).



Ms. Yuki MATSUOKA Head, United Nations Office for Disaster Risk Reduction (UNDRR) Office in Japan

Ms. Matsuoka is the Head of the UNDRR Office in Japan. She joined the UNDRR Headquarters (Geneva) in 2004 as a Programme Officer, and then served as Special Assistant to Director, before assuming the position as the Head of the UNDRR Office in Japan. She was engaged in the overall coordination of the Second UN World Conference on Disaster Reduction (January 2005 in Kobe) and the Third UN World Conference on Disaster Risk Reduction (March 2015 in Sendai), including the processes to develop the Hyogo Framework for Action 2005-2015 and the Sendai Framework for Disaster Risk Reduction 2015-2030. Prior to UNDRR, she worked as Special Adviser of the Ministry of Foreign Affairs of Japan (at the Permanent Mission of Japan to the United Nations in Geneva). In cooperation with stakeholders around the world, she has been working on promoting the implementation of the Sendai Framework. She holds PhD in Global Environmental Studies.

Ms. Maria Alejandra MUÑOZ SEMINARIO Vice President,
Government of Ecuador

Maria Alejandra Muñoz Seminario is the Vice President of the Republic of Ecuador. She was elected Vice President, after being appointed on July 17, 2020 by the National Assembly. Maria Alejandra Muñoz Seminario is the third woman in the country's history to hold this position and is the 51st Vice President of Ecuador. She has previously held numerous positions in the public sector, including Director General of the National Customs Service of Ecuador (SENAE), Undersecretary of the Presidential Agenda, Undersecretary-General of Government, and Adviser to the legal Undersecretary of the Presidency of the Republic of Ecuador.

She has 19 years of experience in law practice, mainly in the areas of public law, business, tax and human rights. She has also served previously as a professor of Administrative Law at Universidad Espíritu Santo. She holds a Bachelor's degree in Social and Political Sciences from Universidad Espíritu Santo, and the degree of Lawyer of the Courts and Tribunals of the Republic of Ecuador with business and tax law minors. She holds a Master's degree in violence prevention and women's inclusion from the Psychology Faculty at the University of Salamanca, Spain. She is certified by the Global Economic and Political Environment, Risk Management, Institutional Crisis Management, and Anti-Bribery Practices Program of the Faculty of Justice from the University of Cambridge, London, 2012; and also holds a Leadership and Change Management Program Certification from IESE Business School, Miami, 2014.



Ms. Bambi KRAUS National Tribal Affairs Advisor, Federal Emergency Management Agency (FEMA), Government of the USA

Ms. D. Bambi Kraus is the National Tribal Affairs Advisor for the Federal Emergency Management Agency (FEMA) of the United States Government. She is the point of contact between the FEMA Administrator, Regional Tribal Liaisons, and tribal governments across the country. She is part of FEMA's Intergovernmental Affairs Division, which leads all tribal relations and tribal consultation at FEMA. Previously, Ms. Kraus served for 19 years as the President of the National Association of Tribal Historic Preservation Officers, a national organization of Tribal government officials who implement federal and tribal preservation laws. Since graduating from Stanford University, she has resided in Washington, DC, and has been committed to working with and advocating for Native rights.



Mr. Vijay PADMANABHAN Director, Urban Infrastructure, Southeast Asia Department, Asian Development Bank (ADB)

An Engineer-Urban Planner, Vijay is the Operations Director for urban development and water in the Asian Development Bank's (ADB) Southeast Asia Region and manages a \$4 billion operations. With 24 years of professional experience, he has led multi-sector teams in designing and delivering large and complex projects on urban development, water and sanitation across several countries in the Asia-Pacific Region. He has also led enterprise resource planning for urban local bodies; structured and financially closed private sector projects and helped issue infrastructure bonds in the water and sanitation sector; and structured and successfully implemented emergency and post-conflict assistance projects. He has also served as ADB's Technical Advisor for Urban and Water advising operations across the Region.

Dr. Joy Elamon is the Director General of Kerala Institute of Local Administration (KILA). He is a medical doctor with Masters in Public Health (MPH) and MBBS. Later he served as the Chief Programme Coordinator of Capacity Development for Decentralisation in Kerala Programme at Swiss Agency for Development and Cooperation. Subsequently he became the Moderator of Decentralization Community and Maternal and Child Health Community of UN Solution Exchange of UN Country Team in India. He served Intercooperation Social Development India as its Chief Executive Officer and as Senior Advisor Local Governance for Helvetas Swiss Intercooperation. Later, he was a team member and Technical Advisor for South Asia Climate Proofing and Growth Development.

She is a passionate and global advocate for advancing goals of risk reduction and resilience. Ms. Mizutori assumed her role on 1 March 2018. The role of the UN Office for Disaster Risk Reduction is to support countries and stakeholders in the implementation of the Sendai Framework for Disaster Risk Reduction (2015-2030). The Special Representative ensures the strategic and operational coherence between disaster risk reduction, climate change and sustainable development agendas as well as the linkage with the UN Secretary General's prevention agenda and with humanitarian action. She served in various capacities in the Japanese Ministry of Foreign Affairs. Prior to joining the UN, Ms. Mizutori was Executive Director of the Sainsbury Institute for the Study of Japanese Arts and Cultures, University of East Anglia, UK. Graduated in law from Hitotsubashi University, Tokyo and obtained a Diploma in International Studies from the Diplomatic School of Spain.

Mr. MURAKAWA Soshi served 22 years at the Japanese Government and has engaged mainly in infrastructure policies including international infrastructure cooperation, reconstruction after the Great East Japan Earthquake. Currently he is in charge of national policies to promote community based disaster risk planning, building of volunteer management system and international cooperation for global disaster risk reduction, as Director for public and international relations, Cabinet Office for Disaster Management.



BACKGROUND:

The COVID-19 global health crisis has undoubtedly impacted many aspects of society and the economy. The unprecedented socioeconomic impacts that it has caused have undermined development progress and threatened the achievement of the Sustainable Development Goals. Simultaneously, countries are confronted by the challenges of managing compound risks from the COVID-19 pandemic and natural hazards.

The International Recovery Forum 2021 will feature discussions on lessons for governance, planning, financing, and other key areas which can be applied to the COVID-19 recovery. Building on the IRP COVID-19 Recovery Policy Brief, panelists will consider the unique challenges and opportunities for recovery and building back better from the pandemic and compound disasters.

The online Forum 2021 will have two panel discussions that aim to achieve these objectives:

1. Examine priorities and opportunities to build back better, greener, and more resilient from COVID-19 and compound disasters

The first panel will discuss strategies for building back better, greener, and more resilient from the COVID-19 pandemic and natural hazards. Discussions will include consideration for institutional, financial, and implementation support for launching a green and resilient recovery while balancing immediate recovery needs and goals with priorities for longer-term resilience. Speakers will reflect on lessons from recent and past recovery experiences that can inform priorities and opportunities to build back better.

2. Assess social and economic impacts and identify early lessons learned for sustainable recovery from pandemics and compound disasters. The second panel will delve into cases and early lessons learned for recovery from disasters in countries most affected by the pandemic and natural hazards. It will provide insights from assessing social and economic impacts, as well as planning and financing a sustainable recovery. It will address key issues for vulnerable groups, and consider measures for managing compound risks from the pandemic and natural hazards.
